MADISON COUNTY MILITARY HERITAGE COMMISSION Hall of Heroes Induction Application

The Madison County Military Heritage Commission (MCMHC), a private non-profit 501(c)(3) organization, is dedicated to honoring citizens of Madison County, Alabama, who have served in the armed forces and have been awarded medals for valor. This recognition covers all periods of service since the county was established as part of the Mississippi Territory on December 13, 1808. Each year, the Madison County Military Heritage Commission selects a limited number of individuals for induction into the Madison County Hall of Heroes. Induction is strictly limited to candidates who meet the specific criteria outlined below.

Induction Criteria

- Honorable Discharge: The Veteran must have received an honorable discharge, verified by the Member 2 or Member 4 copy of the DD214 form.
- Valor Award: The Veteran must have earned an individual valor award for heroic actions during combat operations. Documentation of the award, such as a copy of the official citation, must be included with the application. A list of the most common individual valor awards can be found on page 3 of the Induction Application.
- Community Standing: The Veteran must be in good standing in the community. This means they should have no outstanding warrants and no history of conduct that is inconsistent with the values of the Madison County Military Heritage Commission.

Residency Requirements

To qualify for induction, the Veteran must meet **one** of the following residency requirements:

• The Veteran must have entered military service from Madison County and received the valor award during this period of service.

OR

• The Veteran must be a current resident of Madison County and have been a continuous resident for at least three consecutive years prior to the date of application.

What to Submit

Applicants or their sponsors must submit a complete application packet to the Commission, which includes the following documents:

- 1. Induction Application (MCMHC Form 101)
- 2. DD214 showing the type of discharge and listing the valor award under the awards and decorations section.
- 3. Copy of the valor award citation.
- 4. Proof of Madison County residency, verifying the criteria outlined in the Residency Requirements section.

What Happens After the Packet is Submitted

Once a complete application packet is submitted, the Madison County Military Heritage Commission Induction Committee screens and validates it using both Alabama state and federal military records. After validation, the packets are reviewed, and a vote is conducted by the Commission to select the inductees for that year's group.

Due to financial and logistical constraints, the number of inductees is typically limited to six per year. Applications that meet all criteria but are not selected for the current year will be deferred for consideration in the following year's induction cycle.

The Commission conducts its annual screening and selection process from *April through August*, with notification letters sent to selected inductees in *September*. Inductees are formally honored at the Annual Association of the United States Army (AUSA) Veterans Dinner in *November*.
